National Marine Conservation Area – Aquatic Tourism Park (KKPN TWP) Gili Matra that covered 2,954 hectares of Gili Meno, Gili Air and Gili Trawangan is a Marine Conservation Area under the Office of National Marine Conservation Area (BKKPN) Kupang, Directorate General of Marine Space Management, Ministry of Marine Affairs and Fisheries (KKP) of Republic of Indonesia according to:

1. Decision of the Minister of Marine Affairs and Fisheries number KEP.67/MEN/2009 concerning The Appointment of the National Marine Conservation Area Gili Meno, Gili Air and Gili Trawangan in West Nusa Tenggara, and
2. Decision of the Minister of Marine Affairs and Fisheries number 57/KEP-MEN/2014 concerning Management and Zoning Plan for National Marine Conservation Area Gili Meno, Gili Air and Gili Trawangan in West Nusa Tenggara from 2014 to 2034.

In order to regulate and discipline the utilization of National Marine Conservation Area-Aquatic Tourism Park Gili Matra, there are two regulations concerning "Aquatic Nature Tourism" activities. They are:

1. Regulation of the Government number 75 of 2015 about Types and Tariffs of Non-Tax National Income in Ministry of Marine Affairs and Fisheries, and
2. Regulation of the Minister of Marine Affairs and Fisheries number 47/PERMEN-KP/2016 concerning The Utilization of the Marine Conservation Area.

The regulation concerning management and utilization of KKPN-TWP Gili Matra has been communicated to local government, "Aquatic Nature Tourism" entrepreneurs and tourists. Following up the meeting between BKKPN Kupang, PSDKP Benoa Base and Gili Matra's diving entrepreneurs on May 3rd and 10th, 2019 in Gili Air, we ask that the diving entrepreneurs can:

1. convey directly the obligation of having an Entry Ticket to his/her tourist/guest who will dive
2. communicate the number of his/her tourists/guests who dive
3. assist his/her tourist/guest to obtain Entry Ticket

4. protect the sustainability of marine's ecosystem and natural resources by obeying the code of conduct of diving
5. report every activity or incident that threat marine's ecosystem and natural resources in KKPN TWP Gili Matra to BKKPN Kupang through Local office (Wilker) Gili Matra in Bangsal
